Notice is hereby given that on February 11, 2019, the City Council of the City of Stilwell passed a resolution for amendment to the City Charter of Article VI, Section 77 related to the compensation paid to the President of the City Council when filling the position of Acting Mayor.

All requirements of Article XI Section 124 of the City Charter (Amended April 8, 1969) have been met allowing placement of this question on the ballot for the next general election held April 2, 2019.

Ballot title:

**Charter Amendment

That from and after approval of this charter amendment, the President of the Council shall, when filling the position of Acting Mayor, be compensated at the salary level of the Mayor.
