

ORDINANCE NO. 45

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE BOUNDARY TO INCLUDE SUCH TERRITORY, AND DESIGNATING A PORTION OF SUCH TERRITORY AS NANCY ADDITION TO THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. That the following described real property situated adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to wit:

TRACT NO. 1

A tract of land lying in the NW/4, SE/4 and in the E/2, NE/4, SW/4 of Section 34, Township 16 North, Range 25 East, described as follows, to wit: Beginning at a point 458.5 feet South of the Northeast corner of the W/2, NW/4, SE/4; thence South 201.5 feet; thence East 324.0 feet; thence South 390.0 feet; thence West 434.0 feet; thence South 12 degrees -00; East 25.6 feet; thence West 410.6 feet; thence North 49 degrees -00; West 407.6 feet; thence North 349.2 feet; thence East 823.2 feet to the point of beginning, containing 13.50 acres, more or less,

TRACT NO. 2

Beginning at a point 130 yards South of the Northeast corner of the SE/4. NW/4, SE/4 of said Section 34, Township 16 North, Range 25 East; thence due West 778 feet to the West bank of Branch; thence in a Southeasterly direction along said Branch bank to the point of intersection of said Branch with the East line of the E/2, SW/4, SE/4 of Section 34; thence due North along East line of said E/2, W/2, SE/4 of Section 34, 1029 feet to the point of beginning, less and except a tract beginning at the Northwest corner of Lot, Block 4, Allen Addition to the Town of Stilwell, Oklahoma, thence South along the West line of said Lot 2 to the Southwest corner thereof; thence West 24 feet; thence in a Northerly direction to the point of beginning,

a map of which is attached hereto and made a part hereof as though fully described herein.

SECTION 2. That the real property herein described as Tract No. 1 shall be designated as the **NANCY ADDITION** to the City of Stilwell, Oklahoma.
