

ORDINANCE NO. 134

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY, AND DESIGNATING SUCH TERRITORY AS THE PATTERSON HEIGHTS ADDITION TO THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to wit:

A subdivision of that portion of the NW/4, SW/4, SW/4 and of the SW/4, NW/4, SW/4 and of the NW/4, SW/4, SW/4 and of the Patterson Block of the 1922 Addition to the City of Stilwell, in Section 2, Township 15 North, Range 25 East, Adair County, Oklahoma, described as follows: Beginning at the Southwest corner of said NW/4, NW/4, SW/4; thence North 232.00 feet; thence North 89 degrees 45' East, 115.00 feet; thence South 4 degrees 16' West, 134.41 feet; thence South 98.00 feet; thence South 89 degrees 45' West, 105.00 feet to the point of beginning; and Beginning at the Southwest corner of said SW/4, NW/4, SW/4; thence North 52.5 feet; thence North 89 degrees 45' East, 210.00 feet; thence North 472.50 feet; thence North 89 degrees 45' East 123.00 feet to the Southwesterly line of State Highway No. 59 right-of-way; thence Southeasterly along a curve having a radius of 856.8 feet, a distance of 200.00 feet; thence South 54 degrees 49' East, 145.0 feet to the Westerly line of the Kansas City Southern Railway Company's right-of-way; thence South 5 degrees 22' West, 99.80 feet; thence North 87 degrees 20' 25" West, 157.32 feet; thence South 4 degrees 08' West, 196.22 feet; thence North 89 degrees 45' East, 161.00 feet; thence Southwesterly along the above said Westerly line a distance of 738.0 feet to the intersection thereof with the South line of the NW/4, SW/4, SW/4; thence South 89 degrees 45' West, 25.00 feet; thence North 100.00 feet; thence South 89 degrees 45' West, 150.00 feet; thence North 146.00 feet; thence South 89 degrees 45' West, 105.00 feet; thence North 78.0 feet to the point of beginning,

a plat of which said property is attached hereto and made a part hereof as though described herein.

SECTION 2. That the real property herein described shall be designated as the **PATTERSON HEIGHTS ADDITION** to the City of Stilwell, Oklahoma, and the boundaries of said City are herewith changed to correspond to the legal description first above given.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. WHEREAS, an immediate necessity exists; therefore, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force and effect from and after its passage and approval.
