

ORDINANCE NO. 276

AN ORDINANCE FIXING RATES FOR WATER AND SEWER EFFECTIVE JULY, 1, 1996.

BE IT ORDAINED, by the Mayor and Council of the City of Stilwell, Oklahoma:

SECTION 1. Effective July 1, 1996, the monthly rate for residential water use shall be \$5.40 base plus \$.80 per thousand for 1000 to 10,000 gallons, and thereafter \$.85 per thousand for the next 10,000 gallons, and \$.90 per thousand for all over 20,000 gallons.

SECTION 2. Effective July 1, 1996, the monthly rates for commercial water use shall be \$13.00 base plus \$.80 per thousand for 1,000 gallons to 10,000 gallons, and thereafter \$.85 per thousand for the next 10,000 gallons, and \$.90 per thousand for all over 20,000 gallons.

SECTION 3. Effective July 1, 1996, the monthly rates for industrial water use shall be \$.96 per thousand gallons of water used.

SECTION 4. Effective July 1, 1997, the monthly rate for residential water use shall remain the same as in Section 1 except that the base shall be \$5.80; for commercial use the monthly rate shall remain the same as in Section 2 except the base shall be \$14.00.

SECTION 5. Effective July 1, 1998, the monthly rate for residential water use shall remain the same as in Section 1 except that the base shall be \$6.15; for commercial use the monthly rate shall remain the same as in Section 2 except the base shall be \$14.50.

SECTION 6. Effective July 1, 1999, the monthly rate for residential water use shall remain the same as in Section 1 except that the base shall be \$6.50; for commercial use the monthly rate shall remain the same as in Section 2 except the base shall be \$15.00.

SECTION 7. Effective July 1, 1996, the monthly rates for residential sewer shall be \$3.90 base plus \$.50 per thousand for 1,000 gallons to 12,000 gallons of water used. For commercial sewer the monthly base shall be \$13.00 plus \$.70 per thousand in excess of 1,000 gallons of water used. For industrial sewer the monthly rate shall be \$.82 per thousand gallons of water used.

SECTION 8. Effective July 1, 1997, the monthly rate for residential sewer shall be the same as in Section 7 except the base shall be \$4.30; for commercial sewer the monthly rate shall be the same as in Section 7 except the base shall be \$14.00; and for industrial sewer the monthly rate shall be \$.89 per thousand gallons of water used.

SECTION 9. Effective July 1, 1998, the monthly rate for residential sewer shall be the same as in Section 7 except the base shall be \$4.65; for commercial sewer the monthly rate shall be the same as in Section 7 except the base shall be \$14.50; and for industrial sewer the monthly rate shall be \$.96 per thousand gallons of water used.

SECTION 10. Effective July 1, 1999, the monthly rate for residential sewer shall be the same as in Section 7 except the base shall be \$5.00; for commercial sewer the monthly rate shall be the same as in Section 7 except the base shall be \$15.00.

SECTION 11. This ordinance shall be in full force and effect from and after its passage and approval.
