

ORDINANCE NO. 336

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY AND DESIGNATING SUCH TERRITORY AS THE REPLAT OF BLOCK 7 OF ORIGINAL TOWN OF STILWELL AN ADDITION TO THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to-wit:


A tract of land situated in the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$, of Section 34, Township 16 North, Range 25 East of the Indian Base Meridian Adair County Oklahoma Described as follows: Beginning at the SW Corner of said SE $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$ thence N00°02'10"E along the west boundary of said SE $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$ a distance of 319.00 feet, Thence S89°34'24"E a distance of 302.30 feet. Thence S00°02'10"W a distance of 319.00 feet to a point on the South line of SE $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$, said point being the NE Corner of Lot 2, Block 7 of the original town of Stilwell, Thence N89°34'24"W a distance of 302.3 ft. to the point of beginning. Less the West 70 Ft. thereof for drainage easement, containing 2.23 acres, more or less,


a plat of which said property is attached hereto and made a part hereof as though described herein.

SECTION 2. That the real property herein described shall be designated as the **REPLAT OF BLOCK 7 OF ORIGINAL TOWN OF STILWELL** an Addition to the City of Stilwell, Oklahoma, and the boundaries of said City are hereby changed to correspond to the legal description first above given.

SECTION 3. That all ordinances, parts of ordinances in conflict herewith are here by repealed.
