AN ORDINANCE PROVIDING FOR AN INCREASE IN THE SALARIES FOR THE MAYOR AND THE CLERK TREASURER.


BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, STATE OF OKLAHOMA:

SECTION 1. That the salary of the Mayor of the City of Stilwell, Oklahoma, shall be \$1,000.00 per month, effective at the beginning of the next term of office of the said Mayor.

SECTION 2. That the salary of the Clerk Treasurer of the City of Stilwell, Oklahoma, shall be \$1,500.00 per month, effective at the beginning of the next term of office of the said Clerk Treasurer.
