WHEREAS: certain costs are accrued by the City for each action by the Municipal Court; and WHEREAS, the responsibility for such is the lawful responsibility of the City of Stilwell,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1 - From and after the effective date of this Ordinance there shall be charged and collected by the Clerk of the Municipal Court for costs in each case the sum of \$36 plus other fees required by the state.

SECTION 2 - Ordinance 196, Ordinance 196-A, and Ordinance 196-B are hereby repealed as are all other ordinances or portions thereof which conflict with this Ordinance.
