

ORDINANCE 385-2020-A

AN ORDINANCE PROVIDING CHANGES TO ORDINANCE 385-2020 AND REPEALING ORDINANCE 375

WHEREAS, in order to fulfill the needs of the community, policies and regulations are necessary to provide a framework for care and safety of the citizens of the City of Stilwell; and

WHEREAS, an annual update of fees and permits for activities within the City of Stilwell, as required by Ordinance 385, is of paramount importance for intelligent oversight and fiscal responsibility, and

WHEREAS, the responsibility for such is the lawful responsibility of the City of Stilwell,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

ORDINANCE 385-2020 shall forthwith be amended as per the following:

REQUIRED FEES AND PERMITS

Trash Fees

Trash Fees are included on the monthly Stilwell Utility bill.

FEE SCHEDULE FOR PERMITS AND INSPECTIONS

SECTION 2: Signs

Permanent signs:

- \$.10 per square foot with a minimum of \$10.00 and
- inspection fee of \$25.00 per required inspection

Yard sale and temporary signs:

- No fee

Telecommunications:

- Special Permit (12 Months): \$250
- Annual Renewal: \$200

ARTICLE 5:

TRASH FEES

SECTION 1. The basic rate for collection and removal of garbage and refuse by the City of Stilwell is as follows:

In City Residential Base Rate	<u>\$11.50</u> per month 1 day per week pick-up
Out of City Residential Base Rate	<u>\$16.50</u> per month 1 day per week pick-up
Commercial Base Rate 1	<u>\$27.00</u> per month 1 day per week pick-up
Commercial Base Rate 2	<u>\$29.50</u> per month 2 day per week pick-up
Commercial Base Rate 3	<u>\$32.00</u> per month 3 day per week pick-up
Commercial Base Rate 4	<u>\$34.50</u> per month 4 day per week pick-up
Commercial Base Rate 5	<u>\$37.00</u> per month 5 day per week pick-up

(Commercial rates apply to all Business and non-residential)

SECTION 2. The Dumpster rates for collection and removal of garbage and refuse by the City of Stilwell, Oklahoma are as follows:

4 days per week pick-up		
1st Dumpster	Additional	<u>\$36.00</u> per month
2nd Dumpster	Additional	<u>\$28.00</u> per month
3rd Dumpster	Additional	<u>\$24.00</u> per month
5 days per week pick-up		
1st Dumpster	Additional	<u>\$40.00</u> per month
2nd Dumpster	Additional	<u>\$32.00</u> per month
3rd Dumpster	Additional	<u>\$28.00</u> per month

Short-term dumpster rental will be \$50 for two weeks per dumpster with unlimited dumping.

SECTION 3. All residents who are age 65 or older may elect to receive a 20% discounted rate for residential pick-up per month by making application at the Stilwell City Hall, 503 W. Division Street, Stilwell, Oklahoma. Those already receiving the senior rate will automatically receive the 20% discount on the new rate.

SECTION 4. Out of city trash pick-up is available only for those who live on or adjacent to the Stilwell city boundaries or an established trash route as determined by the Sanitation Department.

ARTICLE 3: Reliability
